I wish to report that on the 26th day of

June, 2009, I delivered to the Office of the Mayor of the City of St. Louis the following board bills that were truly agreed to and finally adopted.

Board Bill No. 64

An Ordinance directing the Director of Streets to temporarily close, barricade, or otherwise impede the flow of traffic on Clemens Avenue at the east curb line of Hamilton Avenue and containing an emergency clause.

Board Bill No. 77

An ordinance authorizing and directing the Street Commissioner to take all necessary actions to honorably designate Burd Avenue as "Pastor Michael Jones Avenue."

Board Bill No. 63

An ordinance authorizing and directing the Mayor and Comptroller of the City of St. Louis to execute, upon receipt of and in consideration of the sum of Two Thousand Dollars (\$2,000.00) and other good and valuable consideration, a Quit Claim Deed to remise, release and forever quit-claim unto Union Electric Company, dba AmerenUE, certain City-owned property located in City Block 3879-S, which property is an irregular parcel fronting an alley and containing 500 square feet, more or less, and containing an emergency clause.

Board Bill No. 95

An ordinance authorizing and directing the Mayor and Comptroller of the City of St. Louis to execute, upon receipt of and in consideration of the sum of Forty-Three Thousand Six Hundred Fifty Dollars (\$43,650.00) and other good and valuable consideration, a Quit Claim Deed to remise, release and forever quit-claim unto Cornerstone/St. Luke's, Inc., certain City-owned property located in City Blocks 4547 and 4548, which property is known as 5632-38 and 5637-49 Enright Avenue containing 52,860 square feet, more or less, and containing an emergency clause.

Board Bill No. 41

An ordinance recommended by the Board of Public Service to vacate above surface, surface and sub-service rights for vehicle, equestrian and pedestrian travel in the 20 foot wide east-west alley and the easternmost 355.66 feet of the 15 foot wide east-west alley of City Block 1858 as bounded by Cass, Webster, Evans and Francis in the City of St. Louis, Missouri, as hereinafter described, in accordance with Charter authority, and in conformity with Section 14 of Article XXI of the Charter and imposing certain conditions on such vacation.

Board Bill No. 1 (Committee Substitute)

An ordinance making appropriation for payment of Interest, Expenses and Principal of the City's Bonded Indebtedness, establishing City tax rates, and making appropriation for current year expenses of the City Government, Water Division, St. Louis Airport Commission, Affordable Housing Trust Fund, Health Care Trust Fund, Use Tax Excess Trust Fund, Building Demolition Fund, Assessor, Victim's Fund, Communications Division, City Employee Pension Trust Fund, Forest Park Fund, Child Support Unit (Circuit Attorney's Office), Circuit Attorney Training and Collection Fee Funds, Port Administration, Peace Officer Training Fund, Capital Improvement Projects Fund, Capital Improvements Sales Tax Trust Fund, Metro Parks Sales Tax Fund, Centralized Mailroom Internal Service Fund, Tourism Fund, Lateral Sewer Fund, Public Safety Trust Fund, Public Safety Sales Tax Trust Fund, Local Parks Fund, Neighborhood Parks Fund, BJC/City Trust Fund, Miscellaneous Special Funds, Trustee Lease Fund, Riverfront Gaming Fund, Various Grant Funds, Tax Increment District Special Allocation Fund, City Convention and Sports Facility Trust Fund and Employee Benefits Fund (Department of Personnel); for the Fiscal Year beginning July 1, 2009 and ending June 30, 2010, amounting in the aggregate to the sum of Nine Hundred Sixty Million, Eight Hundred Forty One Thousand, Seven Hundred Seventy Eight Dollars (\$960,841,778) which sum is hereby appropriated from Revenue and Special Funds named for the purposes hereinafter enumerated and containing an emergency clause.

Board Bill No. 94

An ordinance recommended by the Parking Commission making appropriation for payment of the operating expenses, capital equipment and improvement expenses, including lease purchase agreements involving Parking Division assets, and debt service expenses of the Parking Division of the Treasurer's Office, Kiel Parking Facilities, Argyle Parking Facility, Chouteau Parking Facility, Williams Paper Parking Facility, Central Downtown Parking Facility, Cupples Parking Facility and Justice Parking Facility for the fiscal year beginning July 1, 2009 and ending June 30, 2010, amounting in the aggregate to the sum of Thirteen Million, Five Hundred Eighty Six Thousand, Three Hundred Fifty Six Dollars (\$13,586,356) and containing an emergency clause.

An ordinance approving a blighting study and redevelopment plan dated February 24, 2009 for the 6323 Arthur Avenue Redevelopment Area (as further defined herein, the "Plan") after finding that said Redevelopment Area ("Area") is blighted as defined in Section 99.320 of the Revised Statutes of Missouri, as amended (the "Statute" being Sections 99.300 to 99.715 RSMo inclusive, as amended); containing a description of the boundaries of the Area in the City of St. Louis ("City"), attached hereto and incorporated herein as Attachment "A", finding that redevelopment and rehabilitation of the Area is in the interest of the public

health, safety, morals and general welfare of the people of the City; approving the Plan attached hereto and incorporated herein as Attachment "B", pursuant to Section 99.430 RSMo, as amended; finding that there is a feasible financial plan for the redevelopment of the Area which affords maximum opportunity for redevelopment of the Area by private enterprise; finding that no property in the Area may be acquired by the Land Clearance for Redevelopment Authority of the City of St. Louis ("LCRA"), a public body corporate and politic created under Missouri law, through the exercise of eminent domain; finding that none of the property within the Area is occupied, but if it should become occupied, the Redeveloper(s) (as defined herein) shall be responsible for providing relocation assistance pursuant to the Plan to any eligible occupants displaced as a result of implementation of the Plan; finding that financial aid may be necessary to enable the Area to be redeveloped in accordance with the Plan; finding that there shall be available up to a five (5) year real estate tax abatement; and pledging cooperation of this St. Louis Board of Aldermen ("Board") and requesting various officials, departments, boards and agencies of the City to cooperate and to exercise their respective powers in a manner consistent with the Plan; and containing a severability clause.

Board Bill No. 34

An ordinance repealing Ordinance 67701 and in lieu thereof enacting a new ordinance prohibiting the issuance of any package or drink liquor licenses for any currently non-licensed premises within the boundaries of the First Ward Liquor Control District, as established herein, for a period of three years from the effective date hereof; containing

exceptions and allowing, during the moratorium period, for the transfer of existing licenses, under certain circumstances, and the issuance of a drink license to persons operating a restaurant at a previously non-licensed premises and containing an emergency clause.

An Ordinance recommended and approved by the Airport Commission and the Board of Estimate and Apportionment, establishing a program for the short rental of kiosk space at Lambert-St. Louis International Airport® by adopting the Policy and Criteria for the Letting of Kiosks at Lambert-St. Louis International Airport® (the "Kiosk Program") set out in ATTACHMENT "1" to this Ordinance, which is attached hereto and incorporated herein; authorizing the Director of Airports to fully implement the provisions of the Kiosk Program and, with the Airport Commission's approval, to issue, enter into and execute Airport Kiosk Space Permits as provided for in the Kiosk Program; containing an exclusivity clause; and containing a severability clause.

An Ordinance recommended by the Board of Estimate and Apportionment authorizing and directing the Director of Airports and the Comptroller of the City of St. Louis (the "City") to enter into and execute on behalf of the City the "First Amendment To Lease Agreement" (the "First Amendment") to the Lambert-St. Louis International Airport® Lease Agreement AL-542 between the City and Airport Terminal Services, Inc., commencing November 1, 2008, and authorized by City Ordinance No. 68117,

approved October 6, 2008 (the "Agreement"); the First Amendment, which is attached hereto as ATTACHMENT "1" and made a part hereof, was approved by the City's Airport Commission, and its terms are more fully described in Section One of this Ordinance; containing a severability clause; and containing an emergency clause.

Resolution No. 74 83rd Anniversary of Scuggs Memorial Christian Methodist Episcopal Church

WHEREAS, we have been apprised that Scuggs Memorial Christian Methodist Episcopal Church will be celebrating its 83rd Anniversary; and

WHEREAS, the Scuggs Memorial Christian Methodist Episcopal Church was purchased and organized in July 1925 under the leadership of Bishop Randall A. Carter, D.D., A.M., LL. D., Presiding Bishop, assisted by the late Bishop N.C. Cleaves, Dr. Holman Wadsworth Evans, who was then Pastor of Lane Tabernacle and Mrs. Laura Sneed Fox. After the transaction was completed, the name Scuggs Memorial was retained by the congregation because of its historical significance; and

WHEREAS, the church is designed in the "Gothic Revival" style that was prevalent during the latter part of the 19th century and is constructed of Indiana limestone and concrete with Belford stone trimming all around the front and side of the building. It is believed that the church is one of the few remaining Missouri churches (built in the late 1800's) in that architectural style. The church was designed by a local St. Louis architect, Thomas B. Annan, and created in 1884. Members of the congregation added a brick annex to the church in 1964; and

WHEREAS, the purchase price for the church in 1925 was \$45,000.00. The church is grateful to Lane Tabernacle for underwriting the first \$10,000.00 paid on this great building. Rev. R.O. Langford, Secretary of Evangelism served as the first pastor until the Annual Conference meeting in October. In the first few years this newly organized congregation made some progress but found it rather difficult to meet the indebtedness of the church. In 1934, while the General Conference was in session at Scuggs, Rev. T.J. Moppins, pastor and a delegate to the General Conference succeeded in introducing a Resolution to this body to underwrite the indebtedness of Scuggs. In 1944 under the pastorate of Rev. J. Clarence Colclough, the entire debt was liquidated followed by a mortgage burning service led by Bishop Randall A. Carter; and

WHEREAS, the spiritual growth and development of this church is one of everlasting credit to the founding fathers and the succession of consecrated ministers that have led this great congregation to its place of leadership in this community. The growth of the church has been constant with all the Pastors contributing to its success. Scuggs is one of the landmarks of the C.M.E. Church and stands as a monument to the many sacrifices made, not only by the local membership, but by the General Church. One of the Charter Members of Scuggs, Mrs. Jeanette Stith, is still living; and

WHEREAS, the following is the Pastor's Roster at Scuggs from 1925 to the present: Rev. R.O. Langford, Rev. W. T. Moore, Rev. I.C. Nicholson, Rev. H. W. Evans, Rev. H. L. Bolden, Rev. A. W. Womack, Rev. T. L. Moppins, Rev. F. L. Lewis, Rev. J. Reed, Rev. J. C. Harris, Rev. E. W. Walker, Rev. W. L. Liddell, Rev. J. C. Colclough, Rev. J. R. McClain, Rev. D. S. Cunningham, Rev. F. M. Dickey, Rev. J. H. Douglass, Rev. L. L. Reddick III, Rev. J. C. Clay, Rev. W. H. Crenshaw, Rev. G. H. Williams, Rev. D. L. Fitten, Rev. I. A. Hentrel, Rev. J. D. Johnson, Rev. M. L. Lue, Rev. J. T. Stewart and Rev. G. H. Williams; and

WHEREAS, Scuggs has provided a variety of ministries to the Midtown area of St. Louis City. They have operated a Child Abuse Prevention Program, had a strong viable youth and young adult ministry extending its outreach activities into the community, been a site for the Summer Lunch Program, provided after-school tutoring during the school year, and had a weekly Arts and Crafts Program for Senior Adults.

Centennial Celebration will be held in the Joseph Schulte Theatre at St. Louis University High School; and

Her success was won in the face of widespread discrimination, a struggle Dunham championed by refusing to perform at segregated theaters; and

WHEREAS, for her endeavors, Dunham received 10 honorary doctorates, the Presidential Medal of the Arts, the Albert Schweitzer Prize at the Kennedy Center Honors, and membership in the French Legion of Honor, as well as major honors from Brazil and Haiti; and

WHEREAS, after 1967, Dunham lived most of each year in East St. Louis, Illinois, where she struggled to bring the arts to the area. She set up an eclectic compound of artists from around the globe, including Harry Belafonte. Among the free classes offered were dance, African hair-braiding and woodcarving, conversational Creole, Spanish, French and Swahili and more traditional subjects such as aesthetics and social science; and
