REPORT OF CITY OFFICIALS Report of the Clerk of the Board of Aldermen

To the President of the Board of
Aldermen:

I wish to report that on the 29th of
January, 2010, I delivered to the Office of the

Mayor of the City of St. Louis the following board bills that were truly agreed to and finally adopted.

**Board Bill No. 74
(Floor Substitute)**

An ordinance pertaining to a City Health Insurance Committee; amending Section Three of Ordinance 68284, approved March 9, 2009, pertaining to the composition of the City Health Insurance Committee.

Board Bill No. 263

An ordinance recommended by the Airport Commission and the Board of Estimate and Apportionment authorizing and directing the Director of Airports and the Comptroller of the City of St. Louis ("St. Louis") to enter into and execute on behalf of St. Louis a Development Agreement AL-479 substantially in the form as set out in ATTACHMENT "1" to this Ordinance ("Development Agreement"), which is attached hereto and incorporated herein, between St. Louis, the owner and operator of Lambert-St. Louis International Airport® ("Airport"), which is located in St. Louis County, Missouri, and Aero St. Louis, LLC, a limited liability company organized and existing under the laws of the State of Delaware ("Aero"), granting to Aero the exclusive right to develop in phases certain real property located in St. Louis County (the "Premises") consisting of approximately 75.99 acres and improvements thereon commonly known as the "Northern Tract", which is more fully described in Section 1 and EXHIBITS "B" and "C" of the Development Agreement, and to perform all operations and functions that are incidental or necessary to such development subject to and in accordance with the provisions of the Development Agreement; authorizing and directing the Director of Airports and the Comptroller of St. Louis, with the approval of the Airport Commission and the Board of Estimate and Apportionment, to enter into and execute, on behalf of St. Louis in accordance with the terms of the Development Agreement, lease agreements from time to time with Aero for each phase of the development of the Premises under the Development Agreement, substantially in the form as set out in EXHIBIT "G" to the Development Agreement entitled "Prototype Lease Agreement", granting to Aero, subject to the provisions of the Prototype Lease Agreement, the right and privilege to occupy and use the "Leased Premises" as defined therein, to demolish any existing improvements that are not retained improvements, and to construct, repair or make new improvements, for an initial term expiring on the thirty (30) year anniversary of the "Completion Date", unless extended

by Aero under the two (2) additional five (5) year renewal terms, in accordance with Sections 301 and 302 of the Prototype Lease Agreement; authorizing the Director of Airports, on behalf of St. Louis, to enter into and execute agreements or permits with Aero or any sublessees of Aero providing for the collection and payment of Airport fees and charges and/or other operating requirements, as contemplated and provided for in Section 407 of the Prototype Lease Agreement; authorizing the Mayor, the Comptroller, the Register, the City Counselor, the Director of Airports, and other appropriate officers, agents, and employees of St. Louis, with the advice of the Director of Airports, to enter into and execute on behalf of St. Louis and in St. Louis' best interest any attendant or related documents, agreements, permits, amendments, affidavits, certifications, or instruments deemed necessary to effectuate the terms set forth in the Development Agreement, the Prototype Lease Agreement, and/or deemed necessary to preserve and protect St. Louis' interest, and/or to take such actions as may be necessary or appropriate in connection with the consummation of the transactions contemplated herein; providing that the provisions set forth in this Ordinance shall be applicable exclusively to the agreements, documents, permits, affidavits, certifications, and instruments approved, contemplated, and/or authorized by this Ordinance; and containing severability and emergency clauses.

Board Bill No. 264

An ordinance recommended and approved by the Airport Commission and the Board of Estimate and Apportionment, authorizing and directing the Mayor and the Comptroller on behalf of the City of St. Louis (the "City") the owner and operator of Lambert-St. Louis International Airport® (the "Airport") to accept and execute on behalf of the City a certain grant agreement offered by the Missouri Highways and Transportation Commission (the "Grant Agreement") for the development of air service improvements at the Airport for a maximum obligation of Eight Hundred Twenty-Three Thousand Five Hundred Dollars (\$823,500) for the reimbursement of direct costs associated with the projects funded under the Grant Agreement; and containing an emergency clause.

Board Bill No. 266

An Ordinance recommended and approved by the Board of Estimate and Apportionment authorizing and directing the Director of Airports and the Comptroller of the City of St. Louis (the "City") to enter into and execute on behalf of the City the "First Amendment To Lambert-St. Louis

International Airports® (the "Airport") Concession Agreement (Public Communications Services)" (the "First Amendment") to the Airport Public Communications Services Concession Agreement AL-434, dated December 16, 2008, between the City and Power Station LLC (the "Concessionaire"), a corporation organized and existing under the laws of the State of Nevada, and authorized by City Ordinance No. 68179, approved November 24, 2008 (the "Agreement"); the First Amendment, which is attached hereto as ATTACHMENT "1" and made a part hereto, was approved by the City's Airport Commission, and its terms are more fully described in Section One of this Ordinance; containing a severability clause; and containing an emergency clause.

(Committee Substitute)**

An ordinance pertaining to failure to take out a license in the City of St. Louis; amending subsection 8.02.170 of the Revised Code of the City of St. Louis, pertaining to failure to take out license; containing an emergency clause.

Resolution No. 269

Emeritus Reverend Cleo King

WHEREAS, Emeritus Reverend Cleo King was born on December 17, 1929 in West Point, Mississippi to Jasper and Mary Randel King. Both parents, five brothers, John, Willie, Eddie, Curtis and Moses; one sister, Mable G. Brown, and one grandson, Christopher T. King preceded him in death; and

WHEREAS, he was baptized at an early age and attended school in Mississippi. Cleo joined the U.S. Army and served in the Korean War and was honorably discharged in 1952. Reverend King received his Master's in Christian Behavior in the New Word Theological Seminary in June of 1994; and

WHEREAS, in 1952, he married Annie Bell Rice, who preceded him in death. To this union two children were born, Damita and Fernandez. He had two other children, Alvin and Harriet; and

WHEREAS, in 1963, Cleo met and married Ms. Earlie B. Johnson. To this union four children were born, DeFreitas, Ogreita, Everett and Angela; and

WHEREAS, Reverend King worked for the U.S. Postal Service for 35 years and as a Security Guard for Kroger for many years. He was a member of Union Tabernacle M.B.

Church under the leadership of Reverend A. Springfield until his death; and

WHEREAS, Reverend Cleo King was crowned and served as a deacon for many years until he accepted his calling to the ministry on July 13, 1975, where he received his preacher's license and a certificate as an ordained minister on April 17, 1977; and

WHEREAS, Pastor King became the pastor of the Hopewell M.B. Church in East St. Louis, Illinois in 1979. After leaving Hopewell, he was lead by God to organize Siloam M.B. Church with his wife, four youngest children and Reverend and Sister John Bridgeforth; and

WHEREAS, Reverend King opened the church doors every Sunday night to help ministers preach God's word. Reverend King was known for starting on time and willing to help out. Reverend King was a member of the St. Louis Minister Alliance, where he was the financial secretary and then became the President. He also was a member of the St. Louis Pastor's Conference for many years where he was the financial secretary for Berean House; and

WHEREAS, Emeritus King served as Pastor of Siloam for twenty-five years until his health failed. Under his leadership, three deacons were crowned and four ministers were born and ordained. He received certificates in Best 1-V Christ Centered Counseling (Urge Control) January 14, 1993, and Best 1-11 Advanced Interactional Strategies August 17, 1991; and

WHEREAS, Pastor King departed this life on January 13, 2010 at 10:00 a.m. He leaves to cherish his memories: his loving wife for 46 years, Mrs. Earline King; three sons, Fernandez (Cereatha) of Arlington, Texas, Alvin Higginbottom and Pastor Everett (Michelle); five daughters, Damita, Harriet, DeFreitas, Ogreita and Angela (Reverend Charles, Jr.) Jones; three brothers, William (Sally), Morise (Mary) and Robert King; one sister, Ruby King of Chicago, Illinois; 14 grandchildren: Andre (Marni), Lashawna, India, Antwon, Jordan, Christian (Henry) McCulley, Erica, Natasha, Jazmine, Charmelle, Chasidy, Omina, Malik and Precious; 9 great-grandchildren; the Siloam Church family and a host of sister-in-laws, brother-in-laws, nieces, nephews, cousins and friends.

CITY PROPERTY HOLDINGS, LLC
of the City of St. Louis
Enhanced Enterprise Zone**

WHEREAS, by Ordinance No. 67350 this St. Louis Board of Aldermen (the "Board") authorized the Mayor, on behalf of the City of St. Louis (the "City"), to request the designation of a certain area of the City, as more fully described in said ordinance approved December 11, 2006 as an Enhanced Enterprise Zone ("EEZ") eligible for the tax incentives provided in Sections 135.950 through 135.973, inclusive, R.S.MO. (2000) as amended (the "Statute"); and

WHEREAS, the Statute allows, in certain circumstances and subject to certain conditions, the ad valorem taxes which would otherwise be due on subsequent real estate improvements made in EEZ areas to be abated up to 100% for a period not to exceed 25 years from the date the original EEZ Area was so designated, or until December 11, 2031; and

WHEREAS, Ordinance No. 67350 provides for a ten (10) year abatement of taxes on real property in the EEZ in accordance with the requirements of Section 135.963 of the Statute, as amended from time to time, subject to certain terms and conditions; and

WHEREAS, Ordinance No. 67350 provides for the Enhanced Enterprise Zone Board (the "EEZ Board") to review plans for subsequent improvements on real property in the EEZ (the "Subsequent Improvements") and to recommend to this Board the extent to which tax abatement should be granted therefor; and

WHEREAS, City Property Holdings, LLC is renovating property located at 5229-31 Manchester Avenue; resulting in Subsequent Improvements; and

WHEREAS, it is estimated that the Subsequent Improvements will cost approximately \$860,000.00; and will result in 30 new jobs; and

WHEREAS, EEZ Board has reviewed plans for City Property Holdings, LLC Subsequent Improvements and recommends that the ad valorem taxes that would otherwise be imposed on, Subsequent Improvements be abated fully for a period of ten (10) years; and

WHEREAS, City Property Holdings, LLC began the Subsequent Improvements after January 11, 2007, the effective date of Ordinance No. 67350; and

WHEREAS, Section 135.963 of the Statute provides that no abatement shall be

granted except upon approval of an authorizing resolution by the governing authority having jurisdiction over the enterprise zone area following a public hearing held by said governing authority for the purpose of obtaining the opinions and suggestions of residents of political subdivision in the area affected and published in a newspaper of general circulation in the area to be affected by the exemption at least twenty (20) days prior to the hearing but not more than thirty (30) days prior to the hearing, stating the time, location, date and purpose of the hearing; and

WHEREAS, such public hearing was held on the _____ day of _____, 200___, notice of which was given in accordance with the requirements of the Statutes as described above, and all interested parties had the opportunity to be heard at said public hearing.

NOW, THEREFORE, be it resolved by the St. Louis Board of Aldermen as follows:

1. The Subsequent Improvements for property at _____ shall be fully exempt from the ad valorem taxes, which would otherwise be imposed thereon, for a period of ten (10) years.
2. For purposes of calculating the tax liability for the Subsequent Improvements, any increase in the assessment of any improvements, from the assessment in effect for such improvements as of January 1, 2009, shall be deemed attributable to the Subsequent Improvements.
3. In accordance with Section 135.963.2 of the Statute, a copy of this resolution shall be forwarded to the Director of Missouri Department of Economic Development within thirty (30) days of its approval.
