

**ORDINANCE 66764**

**INTRODUCED BY ALDERMAN GREGORY CARTER**

1 An ordinance prohibiting the issuance of any package or drink liquor licenses for any currently non-  
2 licensed premises within the boundaries of the Twenty-Seventh Ward Liquor Control District, as  
3 established herein, for a period of four years from the effective date hereof; containing an exception  
4 allowing, during the moratorium period, for the transfer of existing licenses, under certain  
5 circumstances, and the issuance of a drink license to persons operating a restaurant at a previously  
6 non-licensed premises; and containing an emergency clause.

7 **BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:**

8 **SECTION ONE. LEGISLATIVE FINDINGS.**

9           The existence of alcoholic beverage establishments appears to contribute directly to  
10 numerous peace, health, safety and general welfare problems including loitering, littering, drug  
11 trafficking, prostitution, public drunkenness, defacement and damaging of structures, pedestrian  
12 obstructions, as well as traffic circulation, parking and noise problems on public streets and  
13 neighborhood lots. The existence of such problems creates serious impacts on the health, safety and  
14 welfare of residents of single- and multiple-family within the district, including fear for the safety  
15 of children, elderly residents and of visitors to the district. The problems also contribute to the  
16 deterioration of the neighborhood and concomitant devaluation of property and destruction of  
17 community values and quality of life. The number of establishments selling alcoholic beverages and  
18 the associated problems discourage more desirable and needed commercial uses in the area. In order  
19 to preserve the residential character and the neighborhood-serving commercial uses of the area, there  
20 shall be a moratorium on the issuance of new liquor licenses with the area beginning at the  
21 intersection of the centerlines of Alcott Ave. and Interstate 70, and proceeding along the centerlines

1 in generally clockwise direction northwest to the city limits, northeast along the city limits to Park  
2 Ln., south to McLaran Ave., west to Trafford Ln., south to Norfolk and Western Railway tracks,  
3 southeast to Riverview Blvd., north to McLaran Ave., east to Oriole Ave., southwest to Switzer  
4 Ave., southeast to N. Broadway, south to N. Calvary St., south to Calvary Ave., southwest to West  
5 Florissant Ave., northwest to Alcott Ave., southwest to Harney Ave., northwest to Beacon Ave.,  
6 southwest to Thekla Ave., southeast to Alcott Ave., southwest to the point of beginning.

7 . Such area shall be known as the Twenty-Seventh Ward Liquor Control Area.

8 **SECTION TWO.** The Excise Commissioner is hereby prohibited, for a period of four years,  
9 beginning as of the effective date of this Ordinance, from approving the issuance of a package or  
10 drink liquor license for any premises which is located within the boundaries of the Twenty-Seventh  
11 Ward Liquor Control District established in Section One of this ordinance.

12 **SECTION THREE.** Notwithstanding the provisions of Section Two of this Ordinance, the Excise  
13 Commissioner shall have authority to:

14 (1) Approve transfer of an existing license to another premises within the petition  
15 circle of the currently licensed premises, pursuant to the provisions of subsection (B) of section  
16 14.06.330 of Ordinance 61289; and

17 (2) Issue a drink license for a premises, not licensed as of the effective date of this  
18 Ordinance, which currently is or will be, upon opening, operated as a restaurant, as such term is  
19 defined in section 14.01.390 of Ordinance 61289.

20 (3) Approve the renewal of an existing license under the provisions of Section  
21 14.08.090 of Ordinance 62656

22 **SECTION FOUR. EMERGENCY CLAUSE.**

1                   This being an ordinance for the preservation of public peace, health and safety, it is  
2 hereby declared to be an emergency measure within the meaning of Sections 19 and 20 of Article  
3 IV of the Charter of the City of St. Louis and therefore this ordinance shall become effective  
4 immediately upon its passage and approval by the Mayor.
